



Contestant information/Rules

- Please note that this competition is meant for fun and to bring our community together at the Oak Park. The pit is first come first serve in terms of selection! Being respectful is the number one rule!
- Pit rates have been waived. Please, thank members of the Board of Trustees of the Greenfield Public Recreation District for allowing this to happen.
- Contestants must be 18 + years of age. We support the youth cooking, but for the sake of this particular competition you must be a legal adult.
- Typically, we allow extra add-ons in pit areas. Canopies, tables, and chairs are permitted in your selected area, however, they are subject to the normal rate. The Greenfield Public Recreation District will have amenities/activities around the park for everyone to enjoy, so at this time, we're going to discourage "other extras". Please consult management/the project manager, if there's questions/concerns in this regard. The contest ends at 3:00 PM and the event ends at 5:00 PM; however, we encourage you to enjoy your area for the remainder of the day as a thank you for participating. The park/park gates close at 7:00 PM.
- The type of rib selected is baby back ribs or St. Louis Style Ribs. They must be grilled on site at the BBQ pit you've selected over an open fire. You are allowed to have done your seasoning prep work off site; if necessary to your acclaimed recipe; tins, tinfoil, and pans allowed as long as on your reserved grill.
- The event in and of itself starts at 12:00 PM; however all contestants should be on site by/around 9:00 AM to prep your area and fires. This allots competitors plenty of time.
- Any grease and oils should be properly disposed of and not onto/into park property.
- The contestant and their support team are subject to all the normal park rules during this event. We want everyone to enjoy and for this to become a tradition and with that the regulations need to be kept in mind and respected. Thank you!
